Email report:

In early May a story broke concerning the supposedly destroyed records of the long gun registry. Ontario lawyer Ed Burlew was knee deep in a firearms related court case, when he came across a document provided by the crown prosecutor that could have only been produced from the records of the long gun registry. The long gun registry came into effect in Canada in 1995 under Jean Chretien and was abolished and ordered to be destroyed in 2012 under Stephen Harper. The RCMP is actively denying the allegations. Although it is not the first time the public has suspected the records still secretly exist, looking back to the gun grab following the evacuations during the 2013 High River flood. We will continue to follow this story closely.

Bill C-21 (The gun ban bill) is currently in the second reading stage as of April 23rd, 2021. Parliament will soon break for its summer recess, which is good for gun owners as it slows the march towards gun control by a few months.
