Minor Legal win for the CCFR

When the CCFR first got into the court battle with the federal government, the feds tried to claim "Cabinet Secrecy" in regards to producing evidence for their case. In other words, they don't believe they should be in court or that they should have to justify the gun ban in front of a judge. On May 27th, Associate Chief Justice Jocelyn Gagné ruled that the government would have to get their evidence to her office (Still confidential) and that she would decide if the documents should be kept secret. Does not sound like much of a win, but the reality was many judges likely would have ruled in the governments favour based on precedence.

Canpar Incident

On May 27th Canpar and Loomis had a surprise policy change, they will no longer be shipping firearms and ammunition (Primers and Powder included). This effectively brought the online sale of firearms and ammunition to grinding halt for many as there was limited or no options for shipping to rural areas. Many stores posted immediately after the policy change, they would only be able to do in store purchasing and pickups until a solution was worked out. This was completely unexpected. The CSAAA is in talks with the companies trying to work out a solution.
